Sir,

The Commission in its 523rd meeting held on 7th June, 2017 considered the issue of granting extension in time beyond 31st March, 2017 for utilization of various components of UGC XII Plan General Development Assistance and other plan grant including Merged Schemes which is a part of General Development Assistance to Central Universities/Deemed to be Universities/State Universities and Colleges and approved for extension of time for utilization of various components of UGC XII Plan General Development Assistance and other plan grant including Merged Schemes which is a part of General Development Assistance to Central Universities/Deemed Universities/State Universities and Colleges as per details below:-

- For Building construction already started on or before 31.03.2017 Two years w.e.f. 1.04.2017 to 31.03.2019.
- For other grants already released (except faculty positions) 6 months extension i.e. upto 30.09.2017.
- (iii) During the last financial year of XII Plan period, UGC formulated the new procedure for approval of building projects in March, 2017. As per new procedure, all universities have to obtain the approval of building projects from the Standing Committee of UGC costing more than Rs.75.00 lakhs. As before sending the building projects to Standing Committee of UGC, the universities have to take the approval of their Building



Committee, Finance Committee and Executive Council which resulted delay in submission of their building projects to UGC. Therefore, extension has been granted for one year for starting the constructions projects i.e. 31.03.2018 to such universities only.
